

DXL® BIG + TALL 2025 12 DAYS OF GIFTING GIVEAWAY

OFFICIAL RULES

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN.

Unless otherwise specified by the Sponsor (defined below), these Official Rules apply to all giveaways conducted on Destination XL's social media channels, including but not limited to the feed on the @DestinationXL feeds on Tiktok and Instagram (each referred to individually as a **"Social Platform"**, and collectively as **"Social Platforms"**). The Giveaway will be announced through a post on one or more of the Social Platforms (the **"Giveaway Posting"**). The Giveaway Posting will include how to enter, the entry deadline, and the prize(s) and their respective value(s). All information contained in the Giveaway Posting is incorporated into these Official Rules by reference.

1. ELIGIBILITY: The DXL 2025 12 Days of Gifting Giveaway (the **"Giveaway"**) is open only to individuals who are legal residents of, and physically located in, the United States (including the District of Columbia, Puerto Rico and the U.S. Virgin Islands), who are at least eighteen (18) years of age (or the age of majority in their state of residence, whichever is greater) as of the date of entry (each, an **"Eligible Participant"**). **INTERNET ACCESS AND A VALID EMAIL ACCOUNT IS REQUIRED TO ENTER THE GIVEAWAY.** Employees, officers, directors, shareholders, agents and representatives of Destination XL Group, Inc., Casual Male Retail Store, LLC and Casual Male Store, LLC (hereinafter **"DXL"** or **"Sponsor"**), Power Reviews, Wyng, and their respective advertising and promotion agencies, as well as their immediate family members (herein defined as spouse, parents, siblings, children, and their spouses, regardless of residence) and household members (whether related or not) (collectively **"Giveaway Entities"**), are not eligible to enter or win. Entries received prior to or after the Entry Period for each Drawing will not be accepted.
